Honorable Colleagues:

I hereby submit the Annual Report of the Office of the Westchester County Clerk for fiscal year 2015. The duties of the County Clerk are mandated by the New York State Constitution and by state and local law. These duties are carried out by a dedicated staff that works diligently to serve the public.

The work of the Office of the Westchester County Clerk impacts the lives of residents and businesses throughout our county. Every deed, mortgage, civil or criminal court record, judgment, business certificate or incorporation, and pistol license is filed or recorded in the Office of the Westchester County Clerk.

The Office of the Westchester County Clerk collected \$176,967,999.32 in revenue for 2015, of which \$27,662,046.65 was turned over to the county. The expenditures for the operation of the County Clerk's Office in 2015, totaling \$6,715,856.79, are more than offset by the \$9,112,610.06 in departmental fees collected.

Our office collects fees on behalf of numerous federal and state agencies, and paid out the following 2015 revenue:

- \$59,173,689.13 to the New York State Department of Taxation and Finance for transfer tax
- \$35,336,977.10 to the Metropolitan Transit Authority for mortgage tax
- \$6,285,655.33 to the Office of Court Administration for court filing fees
- \$3,869,489.16 to the State of New York Mortgage Agency for mortgage tax
- \$1,901,438.00 to the New York State Office of Real Property Tax Services
- \$1,436,001.00 to the New York State Commissioner of Education for the Cultural Education Fund
- \$478,738.25 to the New York State Commissioner of Education for the Records Management Improvement Fund
- \$154,360.00 to the New York State Department of State for Notary Public renewals

In 2015, the Office of the Westchester County Clerk saw continuing growth in the electronic submission of records throughout the office. By the end of the year over sixty percent of land records, such as deeds and mortgages, were being submitted to the office electronically as part of a voluntary eRecording initiative. In addition, over eighty-four percent of civil cases were commenced electronically, either pursuant to state mandate, or voluntarily in the case of matrimonial actions.

The Office of the Westchester County Clerk reached a significant milestone in its effort to reduce storage needs in 2015 when space in an interim storage facility in Elmsford was completely vacated. An operational restructuring also resulted in the creation of a unit dedicated to transitioning from reliance on paper court records to images of court records.

Fueled by the successful promotion of a New York City initiative to encourage residents to obtain identification cards in combination with the encouragement of the Westchester County Board of Legislators' Hispanic Affairs Task Force, the Office of the Westchester County Clerk saw a three thousand seven hundred and twenty-six percent increase in the issuance of Westchester County Identification Cards in 2015.

As we enter the new year, my goals for the office of the Westchester County Clerk continue to include improving service through technology, increasing productivity through professional management, and facilitating commerce throughout the county.

I want to thank the County Executive and the County Legislature for continuing to provide sufficient resources to allow the Office of the Westchester County Clerk to meet its mandates and fulfill its fiduciary responsibilities on behalf of the residents of Westchester County.

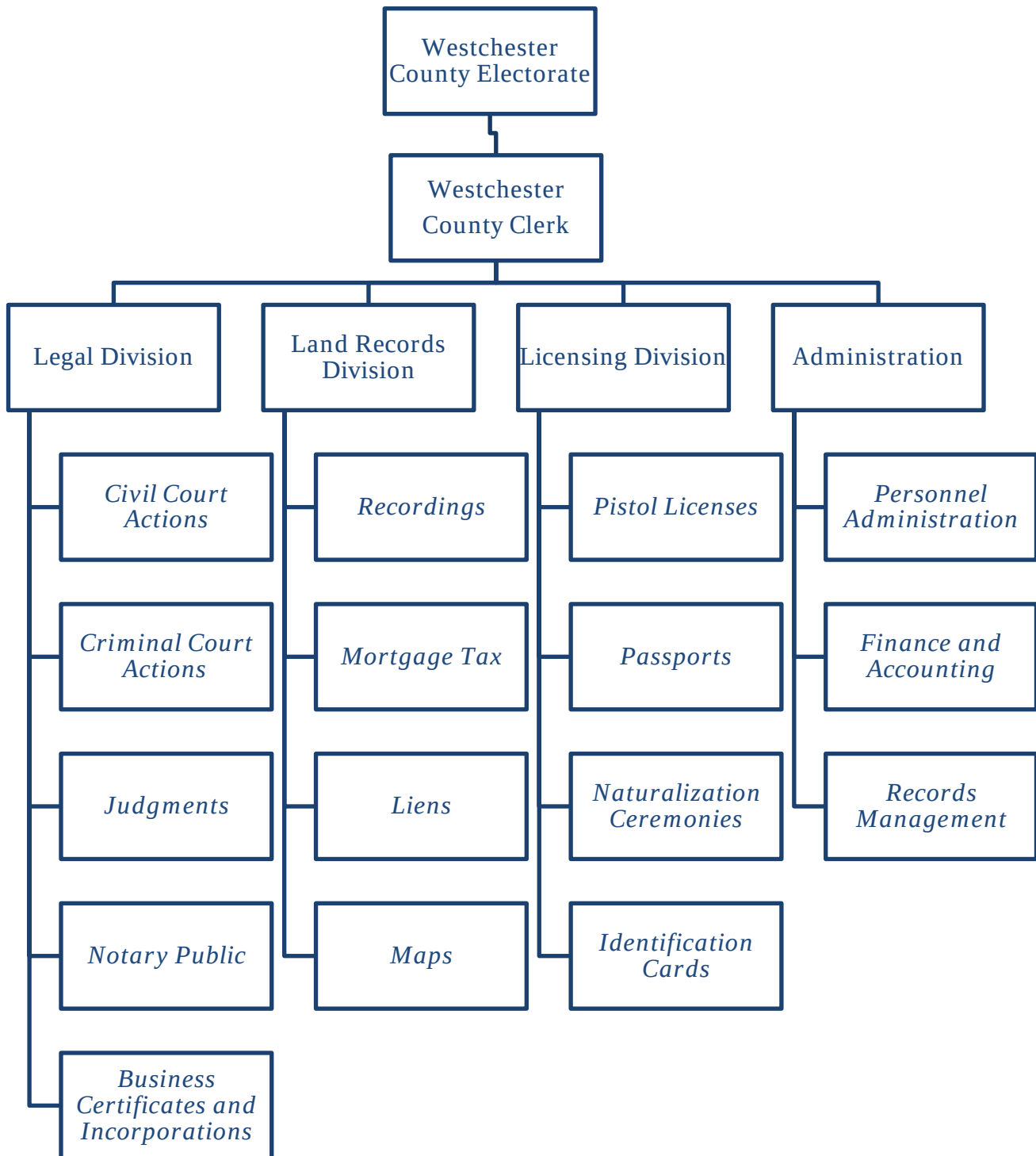

2015 Department Initiatives and Accomplishments

- ✓ **eSolutions Bring Efficiency for Westchester Customers:** The Office of the Westchester County Clerk continues to be a leader in capturing the benefits that technology has to offer. In our Land Records Division, documents such as deeds and mortgages can be recorded and paid for electronically, allowing interests to be secured more quickly and efficiently. By the end of 2015, over sixty percent of the documents submitted to the Land Records Division were submitted electronically as part of a voluntary eRecording program. In our Legal Division, over eighty percent of our 2015 civil cases were commenced electronically through the New York State Courts Electronic Filing (NYSCEF) System. The NYSCEF System also helps our office process documents and transmit them to our partners in the New York State Supreme Court. Finally, our online library of documents available via Westchester Records Online continues to grow, allowing people who want to do business in the county to have quick and easy access to public documents and information.
- ✓ **Storage Space Reduction:** The Westchester County Clerk serves as the Clerk of the Supreme and County Courts and in that role is required to retain court records for their full retention period which can range from a few years to permanent retention. Historically, these court records remained on site in our White Plains office for five years. After five years, court records were transferred to an interim storage facility in Elmsford for another five years. Once court records reached the age of ten years, they were transferred to the County Records Center. The Office of the Westchester County Clerk has worked in conjunction with the Office of Court Administration to develop a program that allows us to designate a scanned image of a court record as the record copy of the document for the purpose of records retention. This program, which we refer to as “document destruction”, allowed us to relinquish all of our space in our interim storage facility in Elmsford in 2015, resulting in a permanent savings of over thirty-four thousand dollars (\$34,000) per year. Further, the volume of documents we will send to the County Records Center on an annual basis has been reduced by over ninety percent saving approximately ten thousand dollars (\$10,000) which compounds annually. Retaining scanned images rather than hard copy court records has allowed us to reduce long-term storage costs while transitioning storage space to other county departments. In addition, with records access greatly improved, staff and customer travel is often reduced, benefitting the environment.
- ✓ **Smart Budgeting Contributes to Reduction in County Tax Levy:** A declining real estate market has brought with it declining revenue in the Office of the Westchester County Clerk. However, the office continues to collect revenue in excess of expenses due to continuing efforts to reduce the cost of the office. Our staffing remains lean, having been reduced by thirty-four percent (34%) over the last ten years. Our cumulative savings resulting from position cuts over the last decade totals over five million dollars.

- ✓ **Licensing Capital Project:** A capital project to upgrade the computer applications used by staffers in our Licensing Division continued in 2015. The new system will support the processing of applications, amendments and recertifications of pistol licenses. In addition, it will support the issuance of Westchester County Identification Cards, the processing of United States Passport Applications, and our role in the Naturalization of new citizens. While the Trades Licensing function was moved to the Department of Consumer Protection on January 1, 2015, our project includes the upgrade of the application supporting trades licensing.
- ✓ **Electronic Recording:** Gone are the days of months-long delays when recording land documents. Electronic recording allows customers to submit land records such as deeds and mortgages to the Office of the Westchester County Clerk electronically by scanning and uploading an image of each document rather than sending in the hard copy document. Electronic recording has been a tremendous success in Westchester County, shortening recording times from days to hours. Errors are corrected more quickly, often in the same day. Document control is improved as original documents are retained by the submitter and cannot be lost or misplaced during transit to and from a recording office. Customers who choose to electronically record no longer pay the cost of postage, overnight mail or courier charges. The County Clerk's Office has eliminated the cost of mailing back rejected and recorded documents, as well as the costs associated with scanning documents. By the end of 2015, over sixty percent of our documents were being submitted electronically through this voluntary alternative to submitting paper documents.
- ✓ **Mobile Passport Office Tours the County:** Our mobile office visits each city and town in Westchester County so that residents are able to apply for a United States Passport close to home. Our mobile office is staffed by a passport agent who is authorized to accept applications and can answer questions about applications and renewals. In addition, our mobile office driver is available to take passport photos. In 2015, over nine hundred passport applications were accepted in our mobile office. Our staffers enjoy helping families who often find it more convenient to travel to our mobile office than to downtown White Plains. In addition, with local post offices reducing or eliminating passport processing hours, residents are seeking this service. Weekend and evening hours are popular with residents whose work schedule makes it hard to visit our office during regular business hours.
- ✓ **Foreclosure Data Captured and Shared to Assist Homeowners in Need:** The Office of the Westchester County Clerk continues to capture information from foreclosure cases aimed at providing Westchester County with the data they need to secure funds to assist residents impacted by the foreclosure crisis. While 2015 saw a reduction in the number of new foreclosure filings, the number of judgments entered soared. The Westchester County Clerk is the Clerk of the Westchester County Supreme Court where foreclosure cases are heard.

The number of facilities the County Clerk stores its records in, down from three facilities at the beginning of 2015. The goal of vacating the storage area at 375 Executive Boulevard in Elmsford was achieved. Over the past eighteen months, five years' worth of court records have been moved out of the facility and the storage space has been turned over to the county so that it can be used by another department.

The increase in passports processed in 2015 resulting from a reduction in passport processing hours offered by local post offices. Our knowledgeable staff assists applicants of all ages in our White Plains office and out of our mobile office which visits communities throughout Westchester County.

By the end of 2015, over sixty-two percent (62%) of all land records, such as deeds and mortgages, were submitted electronically to the Office of the Westchester County Clerk. Each month this voluntary program continues to grow and is paying huge dividends for both our office and the public.

In 2015, over eighty-four percent (84%) of all civil actions were commenced electronically in Westchester County. In recognition of Westchester County's leadership, County Clerk Idoni was invited by the Office of Court Administration to Chair the newly created Supreme Court (Civil) E-Filing Advisory Committee.

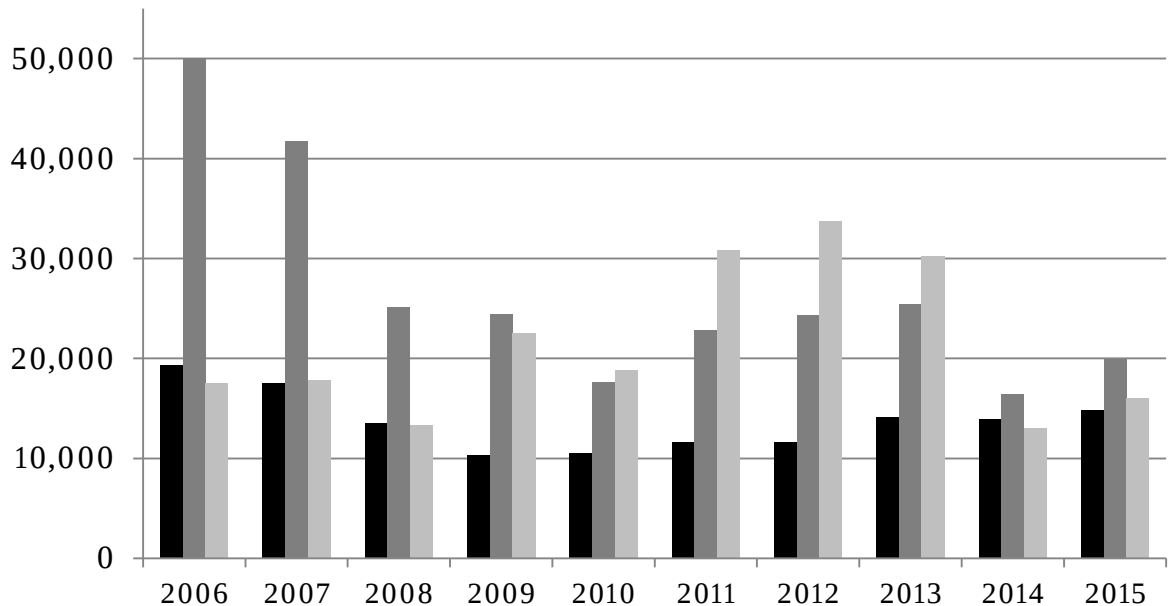

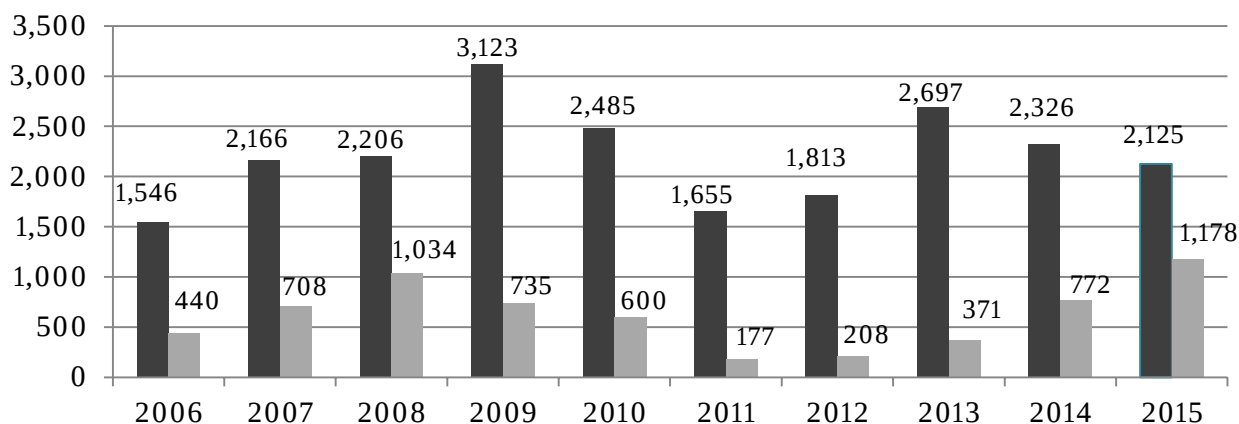

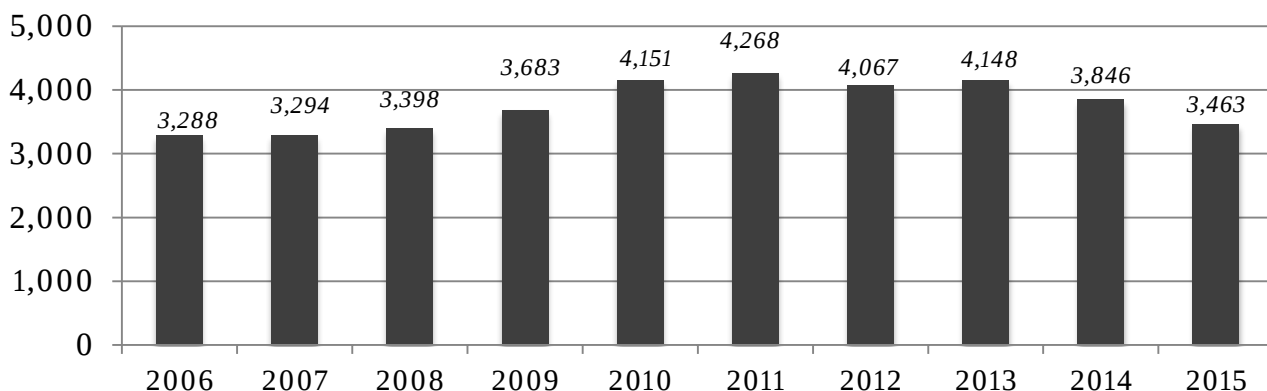

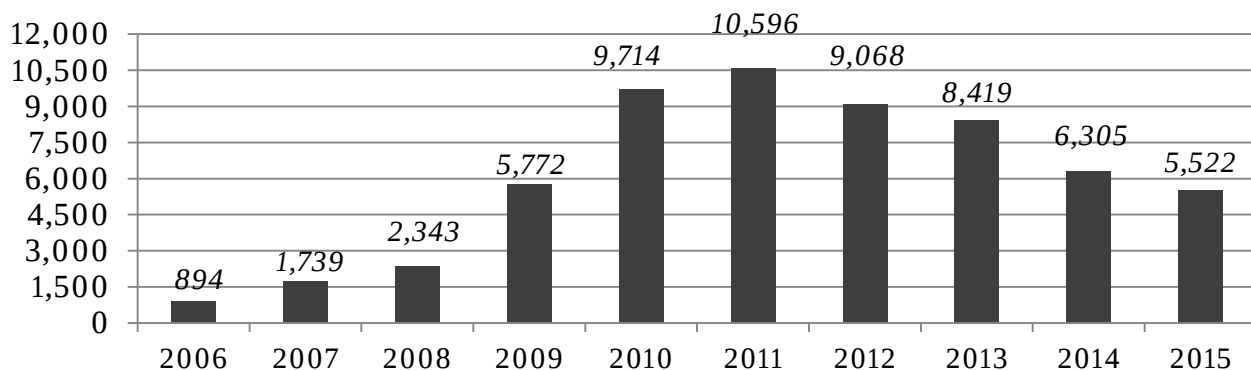
Foreclosure Filings and Judgments
