Honorable Colleagues:

I hereby submit the Annual Report of the Westchester County Clerk for the fiscal year 2017. The duties of the County Clerk are mandated by the New York State Constitution and by federal, state and local law. These duties are carried out by a dedicated staff that works diligently to serve the public.

Each service provided by the County Clerk's office impacts the lives of residents and businesses throughout the county and the nation. Each deed, mortgage, court record, judgment, business certification or incorporation and pistol license is filed and recorded in the Office of the Westchester County Clerk.

The Office of the Westchester County Clerk collected \$210,575,781.87 in revenue in 2017, of which \$27,711,666.05 was turned over to the county. The expenditures for the County Clerk's office in 2017, totaling \$6,765,577, are more than offset by the \$9,031,725 in departmental fees collected.

Our office collects fees on behalf of numerous federal and state agencies, and paid out the following 2017 revenue:

- \$67,554,126.73 to the New York State Department of Taxation and Finance for transfer tax
- \$39,021,058.38 to the Metropolitan Transit Authority for mortgage tax
- \$6,113,447.92 to the Unified Court System for court filing fees
- \$4,400,261.69 to the State of New York Mortgage Agency for mortgage tax
- \$2,113,689.00 to the New York State Office of Real Property Tax Services
- \$1,446,688.50 to the New York State Cultural Education Fund
- \$482,291.25 to the New York State Records Management Improvement Fund
- \$155,080.00 to the New York Department of State for Notary Public renewals

In 2017, the Office of the Westchester County Clerk saw continuing growth in the electronic submission of records throughout the office. By the end of the year, over seventy-three percent of land records such as deeds and mortgages were being submitted to the office electronically as part of a voluntary e-Recording initiative. In addition, almost eighty-six percent of civil cases were commenced electronically; whether pursuant to state mandate or voluntarily in the case of matrimonial cases.

As part of an operational restructuring within our office in 2015 a unit created and completely dedicated to transitioning from reliance of paper documents to images of court records processed relieved us of the need to store over eighteen hundred cubic feet of records, with plans to eliminate two years of storage in the next twelve months.

As we enter the New Year, my goals for the Office of the Westchester County Clerk continue to include service through technology, increasing productivity through professional management, and a customer friendly environment for those who need to visit our office, and facilitating commerce throughout the county through cooperation and effectiveness.

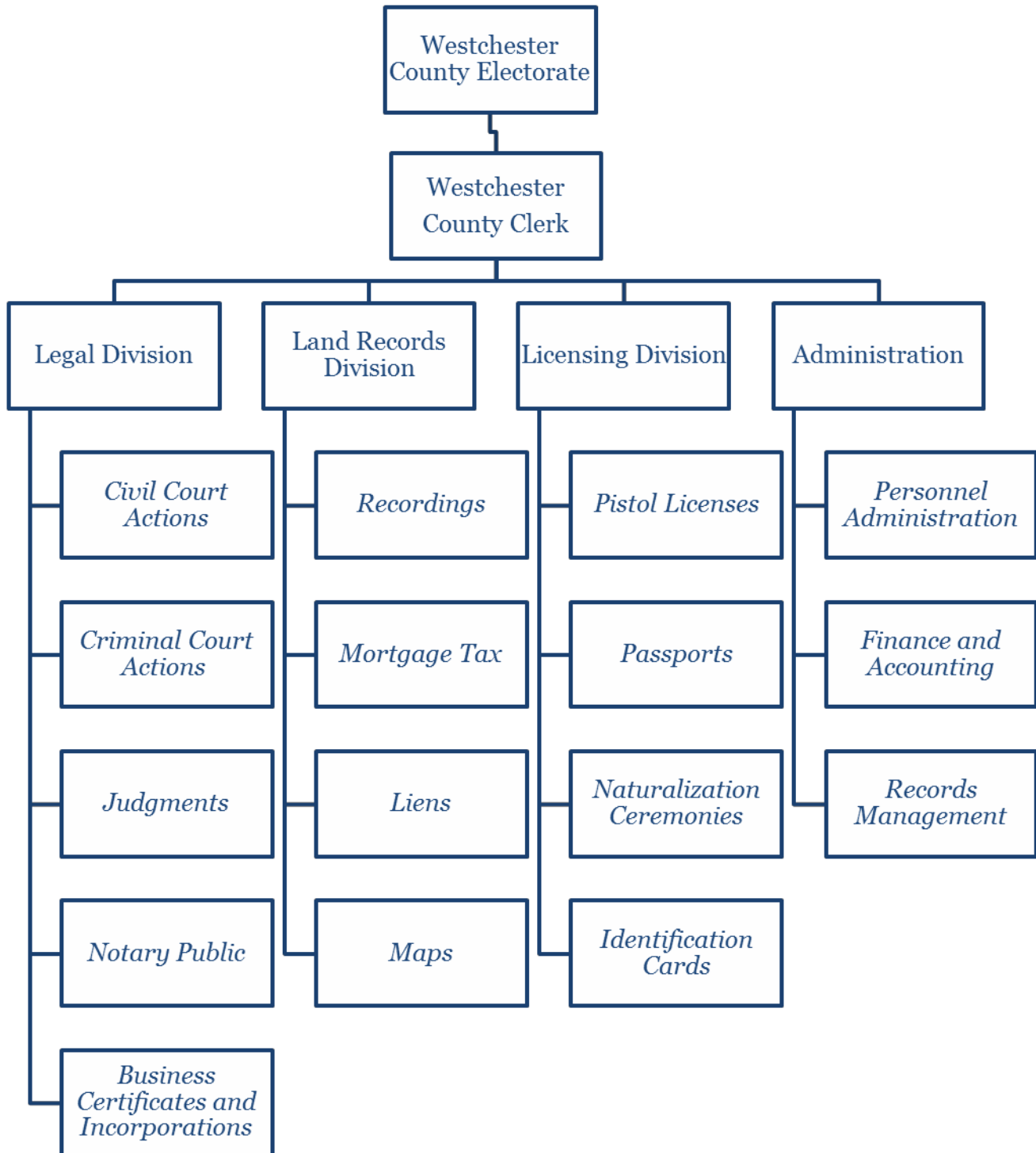

The approximate number of newly naturalized citizens who will have been sworn in by the Westchester County Clerk in 2017. Naturalization ceremonies take place approximately every other Wednesday in the Richard J. Daronco Courthouse.

The approximate percentage of electronically submitted land records, facilitated by the County Board's capital funding in 2008. The success of this voluntary program is paying huge dividends in the form of faster recording times, increased efficiency, and cost-savings.

In recognition of Westchester County's leadership, County Clerk Idoni continues to Chair the New York State Supreme Court (Civil) E-Filing Advisory Committee which advises the Chief Administrative Judge of New York State and received an award from his colleagues throughout the state for our efforts.

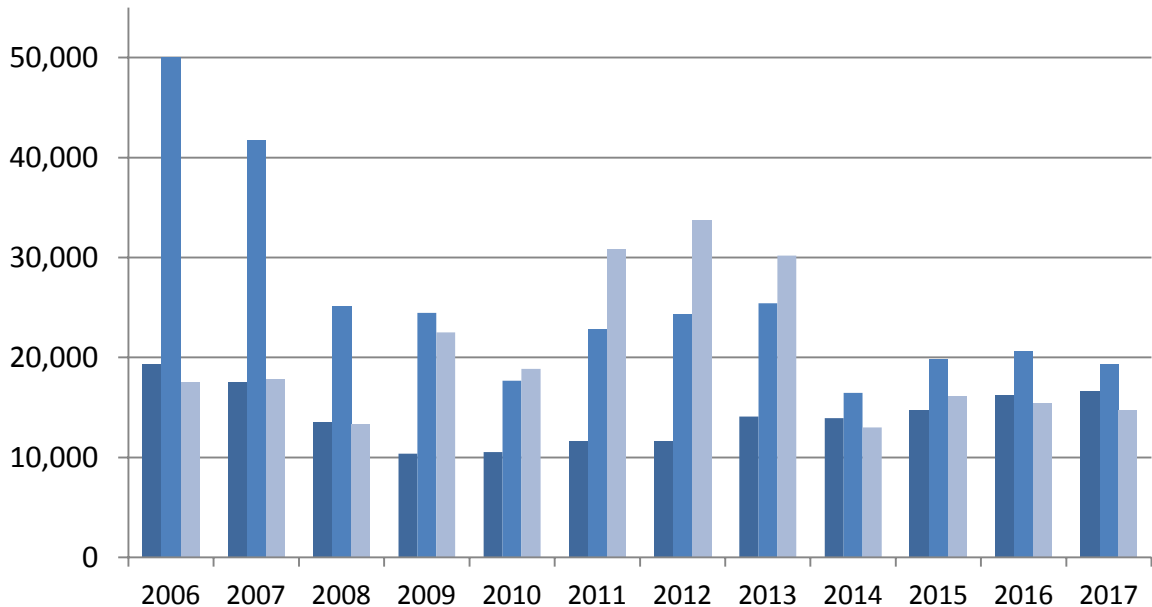

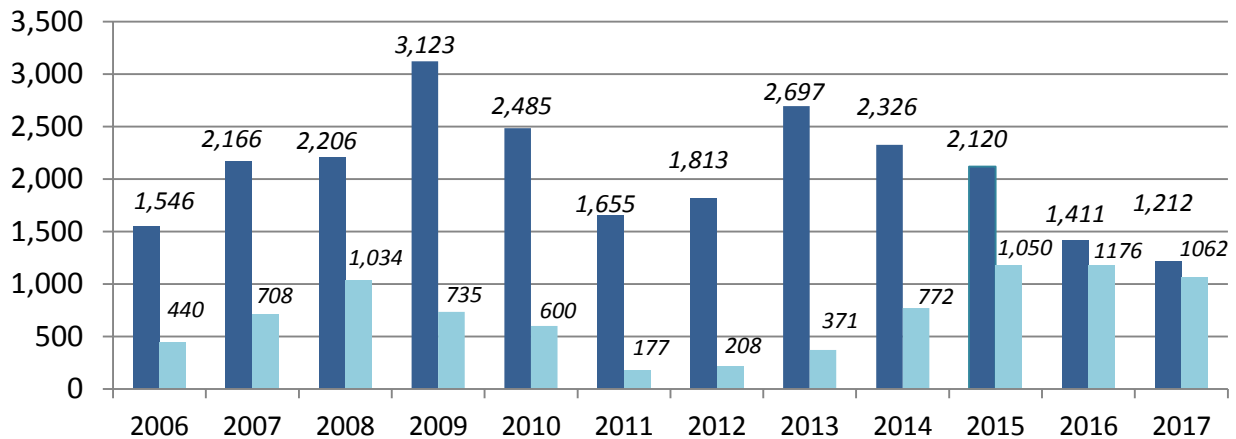

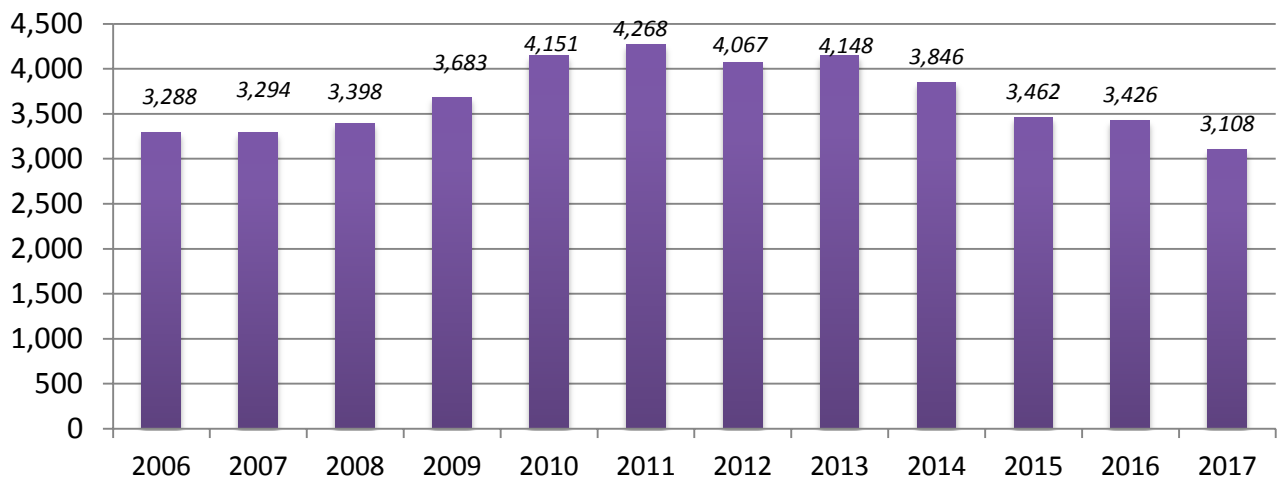

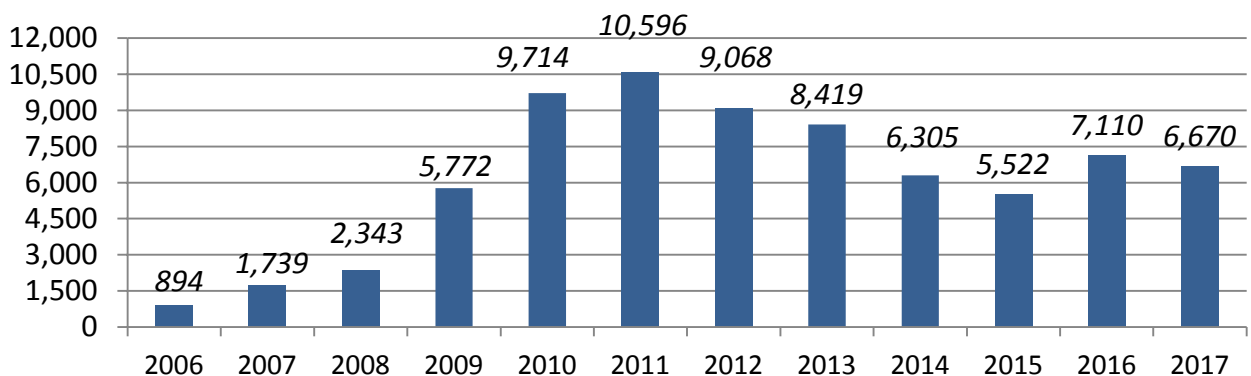
Foreclosure Filings and Judgments
