#### Honorable Colleagues:

I hereby submit the Annual Report of the Westchester County Clerk for the fiscal year 2018. The duties of the County Clerk are mandated by the New York State Constitution and by federal, state and local law. These duties are carried out by a dedicated staff that works diligently to serve the public.

Each service provided by the County Clerk's office impacts the lives of residents and businesses throughout the county and the nation. Each deed, mortgage, court record, judgment, business certification or incorporation and pistol license is filed and recorded in the Office of the Westchester County Clerk.

The Office of the Westchester County Clerk collected \$197,548,904.41 in revenue in 2018, of which \$25,796,996.27 was turned over to the county. The expenditures for the County Clerk's office in 2018, totaling \$6,637,399.00, are more than offset by the \$9,499,021.00 in departmental fees collected.

Our office collects fees on behalf of numerous federal and state agencies, and paid out the following 2018 revenue:

- \$65,282,596.66 to the New York State Department of Taxation and Finance for transfer tax
- \$36,277,016.48 to the Metropolitan Transit Authority for mortgage tax
- \$6,127,286.54 to the Unified Court System for court filing fees
- \$4,054,663.36 to the State of New York Mortgage Agency for mortgage tax
- \$2,025,760.00 to the New York State Office of Real Property Tax Services
- \$1,291,135.50 to the New York State Cultural Education Fund
- \$430,445.00 to the New York State Records Management Improvement Fund
- \$258,760.00 to the New York Department of State for Notary Public renewals

In 2018, the Office of the Westchester County Clerk saw continuing growth in the electronic submission of records throughout the office. By the end of the year, over seventy-one percent of land records such as deeds and mortgages were being submitted to the office electronically as part of a voluntary e-Recording initiative. In addition, over eighty-five percent of civil cases were commenced electronically, whether pursuant to state mandate or voluntarily in the case of matrimonial cases.

As we enter the New Year, my goals for the Office of the Westchester County Clerk continue to include service through technology, increasing productivity through professional management and a customer friendly environment for those who need to visit our office, and facilitating commerce throughout the county through cooperation and effectiveness.





## **Tax Certiorari Proceedings Commenced**




#### **Small Claims Assessment Review Petitions Filed**






